

LICENSE AGREEMENT

This License Agreement ("Agreement") is made on this ____ day of _____ 20__ ("Effective Date"), by and between _____, and its subsidiaries and affiliates (collectively, "Licensee") and Briggs Healthcare, Corporate Headquarters 7887 University Blvd., Clive, IA 50325 ("Briggs").

The Term of this License Agreement is for 1-year of access and agreement will automatically renew each year thereafter, unless terminated by either party (see point 4. Termination).

WHEREAS:

- A. Briggs is engaged in the business of providing proprietary, electronic and paper-based, medical forms, manuals and documentation systems for various healthcare providers.
- B. Licensee licenses the Briggs electronic forms et al to entities that have a unique business unit, physical facility, location, or office (each a "Customer").
- C. Briggs desires to license the individual form fillable PDF clinical content, documentation systems or manuals to Licensee and Licensee desires to obtain a license to use these electronic forms subject to the terms and conditions of this Agreement.

1. Subject Forms, Documentation and Manuals

Briggs will make available to Licensee the Briggs Electronic Forms/Manuals and any updates to the individual forms/manuals made generally available to its licensees during the term of this Agreement.

2. License Grant

Subject to the terms of this Agreement, Briggs grants to Licensee a non-exclusive, non-transferable license to use the Briggs electronic forms. Licensee and Customers will not alter or permit alteration of, modify or permit modification of, create derivative works or permit creation of derivative works of, any Briggs Forms without Briggs's prior written approval. (a) make available the electronic forms to any person on or in connection with the internet or any time-sharing service or service bureau; or (b) use the documentation other than for the permitted use or in any manner or for any purpose or application not expressly permitted by this Agreement. Licensee and Customer shall not itself, or permit any other person to, export, re-export or release, directly or indirectly, the electronic forms to other customers or facilities that are not included within the customers license agreement. For the avoidance of doubt, this Section 2 (License Grant) does not limit Licensee's right to create works without the use of Briggs Forms, or Briggs' Confidential Information.

Once a Customer creates a clinical document based in whole or in part on a Briggs Form, Briggs acknowledges that as a part of that Customer's medical record such form must be retained for a period of several years, and Briggs grants the right to use that specific form so created to that Customer individually for the period the form must be retained by law.

3. Intellectual Property and Copyright

Any and all registered and unregistered rights granted, applied for or otherwise now or hereafter in existence under or related to any patent, copyright, trademark, trade secret, database protection or other intellectual property rights laws, and all similar or equivalent rights or forms of protection, in any part of the world relating to Briggs Forms, including, without limitation, form, format, selection of data items, method of capture (e.g. check box, circled selection, short-answer write-in) and all other elements equivalent to use of equivalent information on paper, constitute intellectual property owned by Briggs ("Briggs Intellectual Property").

Briggs Healthcare does not allow use of any of its intellectual property without a valid license and payment of fees. This prohibition includes the copying and reproduction of forms, in whole or in part, in any format, including paper and electronic. Licensed forms may only be used by the customer who licenses the form. Refer to WHEREAS line B.

4. Termination

Either party may terminate this Agreement at any time. In case of cancellation of subscription, all previously billed subscriptions are non-refundable. In the case of non-payment of any amounts due by Licensee to Briggs, ten (10) days after receipt by Licensee of written notice from Briggs, Briggs may terminate Licensee access to the Briggs forms, documentation systems and manuals. Upon termination, any digital product downloaded to a computer or shared location must be removed/destroyed. (The only exception being a clinical document that is part of a clinical record that must be maintained for a period of time as noted in point 2. License Grant.)
